
1. THE STORY

It represents real-world objects like art, music, in-game items and videos. The unique identifying codes of an NFT creates digital scarcity and gives the holder a verified and public proof of ownership which becomes more valuable as we enter the age of metaverses.

The XRPL is set to support NFTs and smart contract features through federated sidechain integration and we couldn't be more excited.
